No entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance. Illegible entries will not be processed and will be returned to the exhibitor. Returned checks do not constitute a valid entry. ***LBKC Will maintain a wait list:**

Per AKC Regulations **Section 18. Waiting List.** Clubs that limit the number of entries may, at their option, establish a waiting list in order that entries that scratch prior to the event can be replaced. The waiting list shall utilize a "first in – first out" approach. The club must establish a maximum number of entries that may be placed on the wait list. Whether a club is offering a wait list, how many entries are being accepted on the wait list, and the closing date/time of the wait list must be published in the premium list. On the day of the trial, the club may assign entries for absent individuals to those on the wait list who are present at the trial site. If multiple waitlisted individuals are present at the event site, the runs must be assigned in wait-list order. A full refund is to be reimbursed to any entrant whose entry is replaced by a wait-listed entry.

ADDITIONAL SITE INFORMATION

-Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Trial Committee deems the exhibitor to be in violation of this requirement.

-There will be no space provided for crating indoors.

-Lunch will be available for purchase on site. There are NO nearby restaurant or fast food establishments.

-It is not appropriate to scout the trial location prior to the trial date. Many search locations are real-life environments, and such visits may risk the host losing the opportunity to use the location in the future.

Turn right onto Hailey St after 9.7mi, then turn left onto Basey St

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. I (we) certify and represent that the dog entered is not a hazard to persons or other dogs. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim of loss, injury or damage to this dog.
